<p>Samenvatting van de inhoud</p>	<p>In this course, we will :</p> <ul style="list-style-type: none">• Give a clear holistic overview of current and planned (EU) Digital Regulations.• Explain how these Digital Regulations interact and what their impact is (will be) on the financial services sector and its digital transformation initiatives.• Provide examples in practice of the fields in which AI is used, along with the varying impact that this has on a financial services organization and its internal (data) governance framework.• We will focus on the challenges that AI poses when it comes to the implementation of AI governance mechanisms and controls balancing vertical and horizontal approaches in (data) risk management.• Specific attention will be put on some of the most pertinent challenges associated with regulating the use of AI such as eg ensuring transparency, accountability, responsibility, and the ability to make revisions, as well as preventing hidden discrimination, culminating in a need for the adoption of «Responsible AI by design» processes and governance frameworks.
