This supplement dated 15 November 2022 (the "**Supplement N°3**") constitutes a supplement for the purposes of Article 23 of Regulation (EU) 2017/1129, as amended from time to time (the "**Prospectus Regulation**"). The Supplement N°3 is supplemental to, forms part of, and must be read in conjunction with the base prospectus dated 24 May 2022, as amended by a first supplement dated 16 August 2022 (the "**Supplement N°1**") and a second supplement dated 4 October 2022 (the "**Supplement N°2**") (the "**Base Prospectus**"), prepared in connection with the EUR 20,000,000,000 Euro Medium Term Note Programme (the "**Programme**") established by KBC Group NV, incorporated as a limited liability company under the laws of Belgium, with registered office at Havenlaan 2, 1080 Brussels and registered with the Crossroads Bank of Enterprises VAT BE0403.227.515 (Brussels) (the "**Issuer**"). Terms defined in the Base Prospectus or in any document incorporated by reference in the Base Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Supplement N°3.

This Supplement N°3 has been approved by the FSMA, as competent authority under the Prospectus Regulation. This approval does not imply any appraisal of the appropriateness or the merits of any issue under the Programme, nor of the situation of the Issuer.

The Issuer accepts responsibility for the information contained in this Supplement N°3. The Issuer confirms that, to the best of its knowledge (having taken all reasonable care to ensure that such is the case) the information contained in this Supplement N°3 is in accordance with the facts and does not omit anything likely to affect the import of such information.

# I. New information

#### (a) Introduction

#### KBC Group Quarterly Report 3Q2022

On 9 November 2022, the Issuer published its extended quarterly report for the third quarter in the document "*KBC Group Quarterly Report 3Q2022*" accompanied by a press release entitled "*KBC Group: Third-quarter result of 776 million euros*".

In order to ensure that the information contained in the Base Prospectus is up-to-date as required by the Prospectus Regulation, the aforementioned documents will be incorporated by reference in the Base Prospectus.
